5.1.4. The institution adopts the following for redressal of student grievances including sexual harassment and ragging cases.

1. Implementation of guidelines of statutory/regulatory bodies

Grievance and Redressal committee has been constituted in the college as per university norms. College has created a Portal on the website where student can register their grievances online with necessary documents. The information of functioning of CGRC is uploaded on the portal. The CGRC has been displayed on the website to creat awareness among the students, teachers, administrative staff and non-teaching staff. Minutes and Action Taken Report for College Grievance Redressal Cell (CGRC) is prepared.

2. Organization wide awareness and undertakings on policies with zero tolerance.

The college has conducted programs to create the awareness about sexual harassment among thestudents. The "Internal Complaint Committee (ICC) has conducted street play on Sexual Harassment" in the college premises on 27th February 2017.

3. Mechanisms for submission of online/offline students' grievances.

The college has Grievance Redressal Committee. It is performed by the college staff appointed by the principal. The Institution has a transparent mechanism for timely redressed of student grievances including sexual harassment and ragging cases. The Committee has redressed grievances of the students like repairing of the fans, to change the blackboard in the class room, cleanliness of the washroom, misbehavior of the student in the classroom etc. The institution has made provision of complaint boxes which have been fixed left and right-side walls at the entrance space of the college. It has also been fixed in ladies common room to make it available to the girls. The students can compliant about their grievances through online mode. Contact numbers of convener and members of Anti-Ragging Cell and Chairperson and members of Anti-Sexual Harassment Cell have been displayed on the college Website. Students can forward their complaints by using these provisions. The aggrieved students pertaining to their academic, non-academic issues such as assessment, attendance, and miscommunication with the staff are transparently redressed by the committee that has been formed by the college Principal to cater to the needs of the students.

4. Timely Redressal of the grievances through appropriate committees.

Timely actions are taken by the committee on receiving the grievances from the students. The committee is very vigilant in scrutinizing the grievances of the students and examine the reasons and root cause of the problems and act accordingly on time. The grievances of the students received like repairing of the fans, blackboards in the class room, cleanliness of the washroom, misbehavior of the student in the classroom have been redressed by the Committee within a stipulated period of time.


