As per university guidelines Internal assignments for 25 marks were given to the students for the Foundation Course subject. The assignments were collected as per the schedules provided by the teachers. Self-financing courses B.Com (Banking and Insurance) and M.Com have internals in all subjects.

For Semester II, first-year students exams were conducted in offline mode as per the guidelines given by the University of Mumbai for conducting exams at the college level, which include a 50-mark objective paper and a 50-mark subjective paper. For Semesters IV and VI, online exams were conducted as per the guidelines given by the University of Mumbai for conducting exams.
